Helpful Tips

(some tips to make your trip to the notary a success)

1. DO NOT sign the document before visiting the notary. You MUST sign in the presence of the notary.
2. If you have questions about your document or how to complete it, you should reach out to the document's issuer or seek legal representation on how to proceed. A notary is unable to provide instructions or legal advice concerning the completion of your documents.
3. The entire document is required for notarization.
4. If the document requires witnesses, you may be required to bring your own witnesses. The witnesses must be present at the time of signing and cannot be related to the principal signer.
5. The principal signer must be of sound mind and aware of what they are signing.
6. Each signer must provide a legal photo ID such as a driver's license, passport, or military ID. Expiration dates must be current. The name on the document MUST match the name on the ID.
7. Contact the notary service provider with any other questions prior to your visit.
